

PRIVACY POLICY

(based on art. 13 Legislative Decree 196/ 2003 and art. 13 EU Regulation 2016/679)

1. The processing of personal data given to UISP is carried out in compliance with the protection of the privacy of the participants, for the purposes and in the manner mentioned below. The UISP Comitato Territoriale di Firenze is the controller of the data. For any communication including any requests to exercise your legal rights, please contact the Data Controller by e-mail at firenze@uisp.it or by writing to: UISP Comitato Territoriale di Firenze, via Francesco Bocchi 26 - 50126 Florence. The processing of data takes place in compliance with the provisions of the law, with this information and the internal UISP regulations.

2. The data given at the time of the registration for the HALF Marathon Firenze are required for the correct participation of the interested party in the event: if you don't accept the processing of your data by UISP Comitato di Firenze it will not be possible to proceed with the registration. The data therefore serve to prove the registration at the event. The owner, as well as the persons authorized to process the data, assumes a legal obligation of confidentiality.

The provided data may be disclosed with:

- the public institutions for the purposes of legal obligations;
- the Broker and the Insurance Company, through which the policy has been activated;
- the appropriately authorized companies, in carrying out legal obligations and / or carrying out researches for purely statistical purposes;
- the UISP members, the other sports associations / companies affiliated to UISP, to media, as well as they can be disseminated through their own communication channels:

a) as part of the management of the event in the cases provided for by the regulations of the race (example: publication in official communication, race reports and any other information useful for the event);

b) as part of the measures taken by the organizer of the event.

The organization may also give the rights of use provided in this agreement to third parties, its institutional and commercial partners.

The subscriber may also receive from UISP commercial information relating to agreements stipulated by UISP in order to guarantee to its members the purchase of goods and services at the best economic conditions agreed with the suppliers.

Giving access to sensitive data may be necessary in carrying out the obligations required by law (example: criminal certificate for those who work in direct contact with minors), sports regulations (example: medical certificate of unfitness to competitive activity), for particular needs related to organized activities (example: document certifying allergies for participants in sports centres) or for the management of insurance practices aimed at managing an injury. Data about the enrolment, including medical certificates, must be kept, in accordance with the provisions of the Italian Civil Code (Article 2947), for six years. Special/ sensitive data will be processed for the strictly necessary period due to the reason for the acquisition.

3. Personal data will be processed on computer support and on paper, by parties authorized to perform these tasks, constantly identified, appropriately educated and aware of the constraints imposed by the law and who have assumed the legal obligation to confidentiality; using security measures to ensure the confidentiality of the data of the interested party to whom the data refer and the inaccessibility to third parties or unauthorized personnel.

4. The Privacy Policy (based on art. 7 Legislative Decree 196/ 2003 and articles 12-22 EU Regulation 2016/679) gives some rights related to the processing of personal data including:

- the right to know, by requesting to the Data Processor, the existence of data processing that may concern you;
- the right to obtain the updating, rectification or integration of data as well as their cancellation, through the transformation into anonymous form or through the block if the processed violated the law as well as the right to data portability;
- the right to refuse the processing of data in accordance with the aforementioned purposes only for legitimate reasons;
- the right to refuse the processing of data for commercial or promotional purposes, the sending of advertising material or the carrying out of market research;
- the right to submit a complaint to the supervisory authority www.garanteprivacy.it
